Notes from the Board

We have talked and texted MANY times this year about many property related subjects and she has always had suggestions or solutions for me.

I also served as the "point person" to JoAnne, Cindy and Mike. They all now have a voice to the board and our community. Their input to me this last year has been invaluable and has helped facilitate many positive changes. I look forward to continuing as their point person this year.

I want to take a moment to recognize our newly elected board members. Duey Kerper has been elected to serve as our secretary. I welcome two new members, Don Allen as Vice-President and Deannie Price as our member at large respectfully. I look forward to working with them and our beloved treasurer, Ken Marks. Our February 11th board meeting provided us with input from Harry from CareScape with his plans for improving the irrigation system serving the courtyard in each building. The Board walked these areas with Harry on the 18th and is currently considering the bid and our various options.

The board passed a motion to install a lollipop light by the sidewalk behind the mailroom and clubhouse. You should "see" that happening very soon.

On February 26th, we all gathered for a wonderful night of fun and entertainment at our Annual 50's/60's Party. We had over 150 people in attendance. Thank you to all who participated and helped pull off such a fabulous evening. Well done!

We have received two lounges and 2 more chairs for the pool area. Four new replacement large tables and 2 new small tables are in route as you read this.

I had my first official Chat with the Board on February 27th. We had 2 members from the Surprise Fire department make a presentation. They covered two very important topics:

- **Lock Box.** They recommend that owners purchase a 'lock box' which on the exterior of our unit beside the door. We place a key to our unit along with emergency contact information inside the box, and then it's locked by the Fire Department. In the event of a 911 emergency, if the occupant is unable to come to the door, the Fire Department can easily gain access by using the key in the lock box. Otherwise they would have to break the door down to get in. The boxes are only accessible to the Fire Department when they respond to an emergency. Each time we call 911 a fire truck responds with at least 2 certified paramedics on the truck. An ambulance is really only used for transport if necessary. There is a one time charge of \$50 to purchase a box and have it installed by them.
- **Smoke detectors.** Fema states that the life expectancy of a smoke detector is usually 10 years. They can start to lose effectiveness beyond that time frame. The newer smoke detectors have an easy access battery compartment. So, consider having yours replaced.
