Hi Everyone!

So here it is the end of spring or the beginning of summer whichever gathers your fancy. There have been changes to our facility this year and by the time 2016 has ended, most of you will notice improvements that both directly or indirectly affect you.

The clubhouse is the most noticeable improvement and the most visible. As of this writing, only a few pieces of furniture remain to be delivered along with a bit of artwork. The rug at the main entry has now been replaced with a beautiful mosaic that really ties all the colors, furniture, art work and carpet into a spectacular facility. Yes there is more to do but we are finished for a few months.

The next major improvements that you will be aware of is a new bicycle cage being constructed behind building 7 and will house a few dozen bikes securely to prevent some of the thefts like we have experienced in the past. No this will not be a boneyard for old and broken down bilks. Neglected equipment will be removed from the cage. Bike racks will be repositioned in the cage from the existing ones that are in vulnerable placements around the property. Stay tuned!!

Another improvement around the property will be the total replacement of our antiquated drip system for plants and trees. This will be a major undertaking but most likely not too disruptive to the residents.

Finally, the Board has approved the replacement of the elevators in both buildings 3 and 4. This will put us more than half way to our goal of replacing all elevators with new more dependable three phase units with parts available and most likely lower maintenance costs.

Most of the above improvements are reserve funded and are being pursued via the RDA study which we use as the guidelines for improvements at LaSolana.

Many thanks to Annie Marks for another successful Caribbean party and season send off. This was the 10th anniversary of the party and hopefully, there will be many more in the future.

Meet Your Neighbor

"Oh! I'm sure, there are other people more interesting than I am." That's what **Kay Jeffers** from LáSolana's Building 5 said when she was asked to interview for t his article. It was a response heard many times before. And, like everyone else who either refused or reluctantly interviewed for a "Meet Your Neighbor" article, she proved to be far more interesting than she gave herself credit.

The Upper Peninsula of Michigan is where Kay spent her early childhood, not far from the Soo Locks. When her father purchased a hardware store in Red Granite, Wisconsin, her parents and only sister left Michigan. After graduating from Wisconsin's

Berlin High School, Kay attended Deaconess Hospital of Nursing where she received her Registered Nursing Degree (RN) and subsequently her Bachelor of Science in Nursing Degree (BSN) from Alverno College in Milwaukee. Professionally, she retired after 30 years at Pediatric Children's Hospital of Wisconsin.

Kay and her husband George moved to Sun City Grand in 1999 from Greenfield, Wisconsin, a suburb of Milwaukee. They located in the Jasper Point neighborhood, not far from the Bell Road entrance just off Sunrise Boulevard. Unfortunately, George passed in 2001 just two years after their arrival, and not too long after his retirement as a Milwaukee elementary school teacher. Kay considered returning to Wisconsin but decided to stay in the retirement home they had built, and stay she did until moving to LaSolana in January of 2013.

Having two children and four grandchildren remaining in the Milwaukee area may have seemed to some a reason for Kay to return there upon the death of her husband. However, over the years her involvement in a variety of community activities from the very beginning along with an autistic adult son residing in Phoenix have been major incentives to stay.

Among the activities that have engaged Kay are the Sun City Grand Singers since January of 2000 and the Divas since 2006. Since she plays the piano, she accompanies herself at home to the music she sings with the Grand Singers, the Chorale, and the Divas. However, at the request of her next door LaSolana neighbor who likes to sleep late and who is also a musician, she delays her practices until 8:30 a.m. or later. Also, she serves as the music librarian for the Grand Singers, a time consuming task in preparation for their two annual performances.

Over the years Kay has been an active book club member with a liking for historical fiction. She has engaged in some genealogy research of the Cyrus McCormick family on her mother's side and has also become a student of the Bible through her internet research serving church circles associated with Spirit of Grace Lutheran and Desert Palms Presbyterian. Kay has also found time to volunteer at a Lutheran thrift shop in Peoria once a week over several years. When she is not involved with these or her musical activities, Kay looks forward to travel these days with friends and relatives. She has enjoyed several cruises and bus trips within Europe, Canada, Panama, and the U.S. Currently, she is looking forward to attending Macy's Thanksgiving Day Parade as her two oldest granddaughters are participating this coming fall as percussion drum line members of Wisconsin's 300 member band from Greendale High School. When she has time, although she says she never has enough, she stays trim by being physically active through swimming and walking. She enjoys a wide circle of "Grand" friends and that's not surprising because she has a winning personality. Making friends is a gift she has given herself and Kay would be a great gift to give yourself!

New Rental Law

As you may be aware, a new Rental Law passed by the Arizona Legislature went into effect July 24, 2014, and changes how an Association is to treat renters and renter-occupied Dwelling Units. For example, per our Association Attorney, Ekmark & Ekmark, we must now allow renters to be age 45 over, because we allow owners to be age 45 and over.

According to the SCG membership office there are a few more changes to our "rules" because of this recent rental law:

- Owner now keeps their SCG Activity Cards and the card remains active, so they can use the facilities even while the unit is rented out.
- We cannot "require" a copy of the Lease Agreement. We can request something in writing from the owner giving us the required information, such as the name and contact information for any adults occupying the property, the

time period of the lease, including the beginning and ending dates of the tenancy and a description and the license plate numbers of the tenants' vehicles'.

 The Association must allow the owner to run for the Board even if the owner is not occupying their unit because it is rented out.

A copy of the new ruling is on file in the Clubhouse office.

Don't forget to move all items in from around your front door so the cleaning crew can have access to clean around your front door!
