



It is now policy to remove your expansion tanks and water meters.

Home Owner Responsibilities include checking supply lines servicing the toilets, bath sinks (hot and cold), and kitchen sinks (hot and cold) are free of leaks; and that the air conditioning condensation lines at the junction where the condensation lines connect to the drains (under the master bath sink) are regularly cleaned and maintained. This will minimize future claims and prevent damage to the Condominium.

Renovation Policy for LáSolana

While each of us own our units, they are not free-standing homes. This policy compiles the relevant points of the CC&R's that need to be adhered to in order to protect the appearance of the community and structural integrity of the buildings. Regardless of whether Board approval is required, the office must be notified in writing, email is acceptable, of any planned renovation work.
