LaSolana Clubhouse COVID-19 Reopening Guidelines

Your Board of Directors has approved a plan for reopening the Clubhouse effective Monday, March 29th. Reopening guidelines have been developed that comply with CDC requirements and are consistent with SCG COVID-19 Master Reopening and Operations Guidelines. (Attached). Clubhouse use will be limited to LaSolana residents only (owners and renters). Residents who elect to enter the Clubhouse do so at their own risk. LaSolana HOA is not responsible for anyone who may be exposed to COVID-19 or any other health risk.

Hours of Operation

Monday, Wednesday, Thursday, Saturday and Sunday's – 3:00-8:00pm

Tuesday and Friday's -8:30am - 1:00pm

Facilities

All facilities except for the Movie Theater and Computer Room will be open to Clubhouse users. The Computer Room will be available on Tuesday's and Friday's from 8:30am – 1:00pm.

Food and Beverages

Clubhouse users may bring hydration beverages only (coffee, tea, water, etc.) No food is permitted. Coffee will be provided on Tuesday's and Friday's **ONLY until 12:00pm** by LaSolana Staff. Popcorn will continue on **Friday's ONLY.**

General Requirements

- 1. Limit the duration of your Clubhouse visit.
- 2. Clubhouse users should limit groups to 6 or less people.
- 3. Clubhouse users should wash hands and use hand sanitizers frequently.
- 4. Clubhouse users are encouraged, but not required to receive a COVID-19 vaccination and wait 14 days before entering the Clubhouse.
- 5. **DO NOT ENTER** the Clubhouse if you have COVID-19, have been exposed to COVID-19, or are experiencing any symptoms of illness.
- 6. Masks must be worn while in the Clubhouse.
- 7. Entry will require a key card. Doors must not be propped open.
- 8. Tables used for card and/or board games must be kept at least 8 feet apart please do not move tables.
