It was the consensus of the Board and membership that the manner in which the questionnaire was presented was inappropriate. - > Request to have the medium opened for a left-hand turn onto Mountain View from the West End of Building #1. The Board will once again address this issue.
- > Request for a job description for Denise Frazier, Property Manager, City Property Management Company.
